Purpose - Why do we process your personal data?

Your personal data are processed for the purpose of managing all aspects related to your participation in SDGine project (application and selection process).

Data storage period - How long is my personal information kept?

Your personal data will be kept for the time necessary to fulfill the purpose for which it was collected and to determine any liability that may arise from that purpose and the processing of the data.

Legitimization - What is the legal basis for processing your personal data?

The legal bases that legitimize the processing are:

General Data Protection Regulation (EU) 2016/679 (GDPR)

- i. Art 6.1 e): processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller.
- ii. Art 6.1 b) processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract;
- iii. Art. 6.1 c) processing is necessary for compliance with a legal obligation to which the controller is subject;
- iv. Art. 6.1 a) the data subject has given consent to the processing of his or her personal data for one or more specific purposes;

Obligation - Are you obliged to provide this personal data and what are the consequences of not doing so?

The data requested by the Applicant's Portal are strictly necessary to carry out the application and the selection process, for which reason it will not be possible for you to participate if you do not provide them, due to the completely voluntary nature of this submission.

Recipients - Who will be the recipients of your personal data? Are any international transfers of your data envisaged?

Anonymized application documents will be transferred to Madrid+d Foundation for evaluation by Selection Committees. Personal data will not be given in any case.

Your personal data will not be communicated to third parties, unless legally obliged to do so, nor are international transfers of such data planned.









Rights - What are your rights regarding the data provided?

In relation to the data provided, you have the right, with the limitations that may arise from the special characteristics of each processing, to request access to the data, rectification of inaccurate data, as well as the deletion of your data, and to oppose or limit the processing of your data.
